**RESOLUTION ADOPTING THE CASH MANAGEMENT PLAN OF THE  
COUNTY OF CUMBERLAND, NEW JERSEY**

WHEREAS, NJSA 40A:5-14 requires that each local unit shall adopt a cash management plan; and

WHEREAS, the cash management plan shall be approved annually by a majority vote of the governing body; and

WHEREAS, said plan has been prepared and submitted by the Chief Financial Officer; and

WHEREAS, all parties with whom the County works with by way of cash deposits or permitted investments must be made aware of the authority and the limits set forth by the "Cash Management Plan.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Chosen Freeholders, of the County of Cumberland, that the Cash Management Plan, of the County of Cumberland, for the period January 1, 2018 through December 31, 2018 is hereby adopted.

BE IT FURTHER RESOLVED, that the County Treasurer/Chief Financial Officer is hereby charged with administering the "Cash Management Plan,"; and

BE IT FURTHER RESOLVED that the County Treasurer is hereby directed to supply copies of this "Cash Management Plan" to all banks and financial institutions authorized by this plan and to require each person, representing each bank or financial institution, to acknowledge receipt of the plan in writing.

**The Cash Management Plan of the County of Cumberland, New Jersey**

**I. STATEMENT OF PURPOSE.**

This Cash Management Plan (the “Plan”) is prepared pursuant to the provisions of NJSA 40A:5-14 in order to set forth the basis for the deposits and permitted investments of certain public funds of the County, pending the use of such funds for their intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing deposits or otherwise invested in permitted investments hereinafter referred to. The intent of the plan is to provide that the decisions made with regard to the deposits and the permitted investments will be done to insure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any deposit or permitted investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such deposits or permitted investments.

**II. IDENTIFICATION OF FUNDS COVERED BY THE PLAN.**

### Federal and State Grant Funds

### **III. DESIGNATION OF OFFICIALS OF THE COUNTY AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN.**

The County Chief Financial Officer/Treasurer is hereby authorized and directed to deposit and/or invest the funds referred to in the plan. Prior to making any such deposits or any permitted investments, such officials of the County are directed to supply to all depositories or any other parties with whom the deposits or permitted investments are made a written copy of this plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file with such officials.

### **IV. DESIGNATION OF DEPOSITORIES.**

The following banks and financial institutions are hereby designated as official depositories for the deposit of all public funds referred to in the plan, including, any Certificates of Deposit which are not otherwise invested in permitted investments as provided for in this Plan: **All depositories shall provide the County Treasurer documents indicating approval for local government deposits, by the State of New Jersey, Department of Banking and Insurance, pursuant to the Governmental Unit Deposit Protection Act (GUDPA). All depositories shall acknowledge by writing to the County Treasurer receipt of this Plan.**

A. The current operating and payroll checking accounts will be maintained at Investors Bank, serviced by their Glassboro Branch.

**V. DESIGNATION OF BROKERAGE FIRMS AND DEALERS.**

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the designated officials of the County referred to in this plan may deal for purposes of buying and selling securities identified in the plan as permitted investments or otherwise providing for deposits. **The registered principal of any security brokerage firm selling securities to the County shall sign an acknowledgment that the principal has seen and reviewed this cash management plan.**

**VI. CERTIFICATES OF DEPOSIT (not covered by GUDPA in section IV)**

The cash management plan provides for the purchase of certificates of deposit in accordance with the following conditions (NJSA 40A:5-14):

- (1) the funds are initially invested through a public depository as designated above;
- (2) the designated public depository arranges for the deposit of the funds in certificates of deposit in one or more federally insured banks or savings and loans associations, in the account of the County of Cumberland;
- (3) 100 percent of the principal and accrued interest of each certificate of deposit is insured by the Federal Deposit Insurance Corporation;
- (4) the designated public depository acts as custodian for the County with respect to the certificates of deposit issued for the County's account; and
- (5) at the same time that the County's funds are deposited and the certificates of

deposit are issued, the designated public depository receives an amount of deposits from customers of other banks and savings and loan associations, wherever located, equal to the amount of funds initially invested by the County through the designated public depository.

**VII. AUTHORIZED INVESTMENTS.**

Except as otherwise specifically provided for herein, the designated officials are hereby authorized to invest the public funds covered by this plan, to the extent not otherwise held in deposits, in the following permitted investments, within any and all limitations provided by Statute or Regulation (NJSA 40A:5-15.1):

- (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
- (2) Government money market mutual funds;
- (3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
- (4) Bonds or other obligations of the County or bonds or other obligations of component units of the County;
- (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by Local Units;
- (6) Local government investment pools; or
- (7) Deposits with the State of New Jersey Cash Management Fund

**VIII. SAFEKEEPING CUSTODY PAYMENT.**

To the extent that any deposit or permitted investment involves a document or security which is not physically held by the County, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the County to assure that there is no unauthorized use of the funds or the permitted investments or deposits. Purchase of any permitted investments that involve securities shall be executed by a “delivery versus

payment” method to insure that such permitted investments are either received by the County or by a third party custodian prior to or upon the release of the County’s funds.

**IX. ACKNOWLEDGMENT OF RECEIPT OF THE PLAN.**

To assure that all parties with whom the County deals either by way of deposits or permitted investments are aware of the authority and the limits set forth in this plan, all such parties shall be supplied with a copy of this plan in writing and all such parties shall acknowledge the receipt of that plan in writing, a copy of which shall be on file with the designated officials.

**X. REPORTING REQUIREMENTS.**

As of the last day of each month during which this plan is in effect, the County Treasurer shall supply to the Board of Chosen Freeholders at their next regularly scheduled meeting, a written report of any deposits or permitted investments made pursuant to this plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the County as a deposit or a permitted investment.
- B. The amount of securities or deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased or deposits made.
- D. The book value of such deposits or permitted investments.
- E. The earned income on such deposits or permitted investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- F. Any fees incurred to undertake such deposits or permitted investments.
- G. The market value of all deposits or permitted investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the Board of Chosen Freeholders.

**XI. TERM OF THE PLAN.**

This Plan shall be in effect from January 1, 2018 to December 31, 2018. Attached to this plan is a resolution of the Board of Chosen Freeholders of the County of Cumberland approving this plan for said period of time. The plan may be amended from time to time. To the extent that any amendment is adopted by the Board of Chosen Freeholders, the designated officials are directed to supply copies of the amendments to all of the parties who otherwise have received the copy of the originally approved plan, which amendment shall be acknowledged in writing in the same manner as the original plan was so acknowledged.
